

# Wraparound Care Policy

## Our Core Aims

- To provide an affordable, childcare facility for parents/carers.
- To provide a welcoming, safe and secure environment for pupils to have care before and after school hours.

## Introduction

Bury CE Primary School wraparound care is run by Bury CE Primary School and exists to provide high quality out-of-school hour childcare for our parents/carers. The children have the opportunity to extend their day within the school building and to join in a variety of activities on offer.

The care operates term time only (excluding inset days) from:

- 8am – 8.40am
- 3:15pm – 4:30pm or
- 3.15pm – 5.30pm

## Current costs for each session can be obtained from the School Office.

A copy of this policy is provided to all parents of children attending the sessions and is also available on the school website. All parents must complete a registration form for each child attending the sessions and sign the parental agreement to adhere to the terms of this policy.

## Admissions

- Only children attending Bury CE Primary School are eligible to attend wraparound care sessions.
- All places are subject to availability.
- The registration process must be completed prior to the child's commencement of the sessions.

Parents requiring places are welcome to use the wraparound care provided there are spaces and parents/carers have previously completed the registration process.

All wraparound care staff are made aware of the details of a new child.

- Children's attendance is recorded in a register.

## Booking places

- Places for wraparound care are to be booked via MCAS and all payments must be made either through MCAS or through the government's tax free childcare scheme (Childcare Choices). To use the tax free scheme you must first provide the school office with your child/ren's tax free reference number/s.
- Priority for places will be given to those pupils that have pre-booked sessions.
- Subject to space, places can be booked up to the actual day so long as payment has been made in advance of the session.
- Our School reference number is 126022 for tax free childcare payments and our school postcode is RH20 1HB.

## Pricing Policy

- The wraparound care fees cover the cost of staffing, equipment and day-to-day running costs. No discounts will be available for siblings.
- It may be necessary to change fees from time to time, however Parents/Carers will always be given at least one month's notice of this.
- Parents wanting to take advantage of the tax free childcare scheme are required to book and pay by the end of the preceding term. All bookings made after this date must be made through MCAS wraparound care bookings without the benefit of the tax free 20% contribution. The space is not confirmed without the payment via MCAS.
- Refunds are only given in the case of illness/ exceptional circumstance at the discretion of the head teacher
- Fees must be paid via our online payment system MCAS or through the governments tax free childcare scheme

There will be no reduction in charges for children who are picked up early.

In cases of non - payment the child will not be allowed to return to wraparound care until payment has been made.

#### **Staffing**

- The wraparound care staff will have relevant qualifications to provide care for pupils
- At least one member of the team will also hold a paediatric first aid and food hygiene certificate.
- At all times a senior member of staff will also be available in school.

#### **Arrivals and Departures**

- Registers are taken at the start of the session by wraparound care staff. If a child is absent this is checked with the office admin team.
- Parents must call the school office if their child is going to be absent from any session using the usual absence reporting procedures but making it clear that it is absence from the wraparound care.
- Children will continue to stay within the school building once their class have been dismissed. The teacher/TA will then drop children off at wraparound care to ensure they arrive safely.
- Any information/ handover to the wraparound care team will take place at this time. However, wraparound care staff are unable to pass messages to classroom teachers.
- Parents are to bring and collect pupils to/from the hall doors at the start/end of the session.
- Parents/ Carers are responsible for collecting pupils from wraparound care (we will not release pupils without a named adult)

#### **Provision**

- A range of activities are planned for the pupils depending on their interests and needs.
- Wraparound care provision is planned for by our wraparound care team and provides opportunity for pupils to take part in a range of activities.
- Pupils should bring a healthy snack for the beginning of the afternoon wraparound care sessions and must arrive to the morning sessions having had breakfast at home.

#### **Child protection and safeguarding**

In accordance with Bury CE Primary School's child protection and safeguarding arrangements, all wraparound care staff have current DBS clearance and have undergone all required safer recruitment checks.

Wraparound care staff will follow Bury CE Primary School's policies and procedures for child protection and safeguarding as well as its code of conduct.

#### **Emergency evacuation procedures**

In the event of a fire, children and staff will follow Bury CE Primary School's emergency evacuation plan and leave the building in a calm and orderly fashion via the nearest fire exit.

Children attending the school's Wraparound care provision will congregate on the school field opposite the school.

The register will be taken outside and all names checked. There will be an evacuation practice once per academic term.

#### **Risk assessment**

A separate risk assessment will be completed for wraparound care provision.

#### **Behaviour**

Whilst attending wraparound care children are expected to follow the school behaviour policy.

#### **First Aid**

- All accidents will be recorded in the wraparound care accident book, accurately reported to the parents/carer verbally at the end of the day or via telephone call when necessary.
- Accident records will give details of the time, date and nature of the accident; details of the child involved; type and location of the injury; action taken and by whom.
- All incidents are dealt with by a qualified first aider. Parents of any child who becomes unwell during the session will be contacted immediately.

**Medical conditions**

- It is the parent's/carers responsibility to inform the wraparound care staff of any medical conditions/allergies that could affect the child during the session.
- Any prescribed medication needed should be provided to the main school office in line with school Policy.
- It is the parent's responsibility to ensure that all emergency medication is still within its usage date.
- It is the parent's responsibility to inform the main school office of any changes to medical information.
- Where a healthcare plan is in place and already held by the school, it will not be necessary for a new plan to be written, the original plan will be shared with wraparound care staff.
